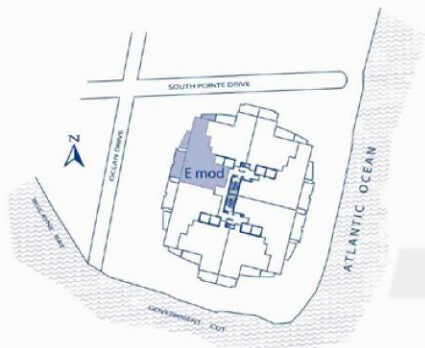

ADDITIONALLY, MEASUREMENTS OF ROOMS SET FORTH OR ANY FLOOR PLAN ARE SUBSTANTIALLY LOWER AT THE OUTLEST POINTS OF EACH ROOM AND AT THE ROOM WHERE A FINISHED REFINISHABLE WITNESSES FOR ANY OUTDOOR ACCORDINGLY, THE AREA OF THE ACTUAL ROOM WILL TYPICALLY BE SMALLER THAN THE PRODUCT OBTAINED BY MULTIPLYING THE STATED LENGTH TIMES WIDTH. ALL DIMENSIONS ARE APPROXIMATE AND ALL FLOOR PLANS AND CONSTRUCTION PLANS ARE SUBJECT TO CHANGE. CEILING HEIGHTS REPRESENTED HEREIN MEASURED FROM THE TOP OF THE LOWER FLOOR SLAB TO THE TOP OF THE UPPER FLOOR SLAB AND EXCLUDES THOSE AREAS WHERE ANY COFFERS, MOLDS, DROP AND/OR SUSPENDED CEILING AND/OR LIGHT FIXTURES MAYBE INSTALLED.
